
Theresa Griffin, MEP (S&D), UK Signatory of the REC Manifesto

He is also a Board Member of eceee (the European Council for an Energy Efficient Economy) and sits on the Steering Committee of the European Coalition for Energy @adrian joyce Savings.




José Lopez, Financial Director, Energies POSIT'IF, France

Wigger Verschoor's main focus consists of reducing CO₂ emissions through energy neutral retrofitting of existing homes in the Netherlands. Urgenda is able to provide this full service to households for under € 35.000, activating demand and generating trust for this necessary step in the fast transition towards a sustainable society. In its Report 2030, Urgenda concludes that a transition to a 100% sustainable energy supply within 20 years

is possible, cheaper and cleaner than staying with fossil fuels, creates 150,000 new jobs, secures a safe energy supply and propels innovation. Together with 900 citizens the Urgenda Foundation won the Climate Case against the Dutch Government on 24th June 2015, forcing it to take more measures against climate change.
